3. I declare that **the list of authors conforms** to academic convention about who should be listed.

I declare that the work **(i) is original**, has NOT been published or offered for prior or simultaneous publication elsewhere in any format, media or language; **(ii) does NOT contain** any statement that are libellous, unlawful or in any way actionable; and, **(iii) will NOT infringe the copyright** or violate the moral rights of any person (*e.g.*, I obtained permission for, and acknowledged the source of, any material included in the article of which I am not the copyright owner).
5. I declare that [check (a) **if applicable** (see notes), and **ONE** of (b) through (d)]:
 - (a) I am duly authorized to deal with the copyright of the co-authors listed above, and so I assign on their behalf non-exclusive interest in the copyright of the work to **ESC** as specified in paragraph 6.
